Terms and Conditions

1. Organiser

- 1.1. This promotion (the “Raffle”) is organised by Doto Global Ltd (the “Organiser”), a company incorporated in the Republic of Mauritius and licensed by the Financial Services Commission (“FSC”) as an Investment Dealer under the Securities Act 2005 (Licence No.: C119023978) with registered office at The Cyberati Lounge, Ground Floor, The Catalyst, Silicon Avenue, 40 Cybercity, 72201 Ebène, Republic of Mauritius.
- 1.2. These Terms are drafted to align with the FSC Guidelines for Advertising and Marketing of Financial Products (effective 1 January 2015) and applicable Mauritian laws, including the Securities Act 2005 and the Data Protection Act 2017. They use fair, clear and not misleading language and include appropriate disclosures.

2. Promotion period

The Raffle runs from 1 September 2025, 00:00 (GMT+3) to 7 September 2025, 23:59 (GMT+3) (“Promotion Period”). Only executed qualifying trades during the Promotion Period count toward entry.

3. Eligibility

- 3.1 Eligible participants must:
 - (a) be 18 years or older and pass the Organiser’s onboarding and KYC/AML checks;
 - (b) hold an active real (live) trading account with the Organiser; demo accounts are not eligible;
 - (c) not be employees, agents, or immediate family members of the Organiser or its affiliates.
- 3.2 Jurisdictional restrictions: The Raffle is void where participation would be unlawful. The Organiser may restrict participation for regulatory reasons.
- 3.3 One natural person = one entrant. Multiple accounts controlled by the same person will be treated as a single entrant.



4. How to participate (no fee to enter)

- 4.1 Instrument: Only trades in XAU500 (Gold CFD symbol) qualify.
- 4.2 Minimum activity: Execute at least 50 qualifying trades during the Promotion Period.
- 4.3 Qualifying trades: A “qualifying trade” is an order that is opened and executed on a live account; pending/cancelled orders and demo trades do not count.
- 4.4 No purchase fee: There is no entry fee for the Raffle; standard trading costs (e.g., spread/commission/overnight funding) apply as per your Client Agreement.

5. Entries and weighting (no guarantee of winning)

- 5.1 Once the minimum activity as per clause 4.2 above is met, you receive entries into the draw. Entries are weighted by your total number of qualifying trades during the Promotion Period as follows:

Qualifying Trades	Entry weighting
50–99	1x
100–149	2x
150–199	3x
200+	4x

- 5.2 More qualifying trades increase your statistical chance in the draw, but do not guarantee selection. The Organiser may cap entries per participant to protect fair participation and market integrity.

6. Prizes

- 6.1 A prize pool of USD 3,000 (Three Thousand US Dollars) is available, awarded to up to 41 (forty-one) participants selected by random draw:

6.2 No substitution or transfer of prizes by participants. The Organiser may substitute a prize with one of equal or greater value if reasonably necessary.

7. Winner selection, notification & verification

7.1 Draw: Winners are selected by a computerised random draw weighted by entry allocations under clause 5, on or about 8 September 2025 under supervision of the Organiser's Compliance function. The Organiser will keep appropriate logs and records.

7.2 Notification: Winners will be notified by email to the registered account address. If a winner cannot be contacted or fails to respond within 7 calendar days, the prize may be forfeited and the Organiser may redraw.

7.3 Verification: Receipt of a prize is subject to the winner successfully completing (where applicable) any KYC/AML/CTF checks, account verification, and compliance review. The Organiser may require reasonable documentation to verify identity and eligibility where applicable.

8. Prize crediting & withdrawals

8.1 Crediting: Prizes are credited in USD or the equivalent value in the account's base currency (using the Organiser's prevailing conversion rate at the time of Doto Global LTD (www.doto.com) is licensed and regulated by the Financial Services Commission, Mauritius as an Investment Dealer under License Number C119023978.



crediting) to the live trading account used for the last qualifying trade, within 5 (five) business days of verification. If the account currency is different, standard conversion rates and fees may apply.

- 8.2 Use and withdrawal: Prize funds are not subject to a turnover requirement and may be used for trading or withdrawn in accordance with normal withdrawal procedures. Withdrawal processing times and standard checks apply.
- 8.3 Taxes: Participants are responsible for any applicable taxes or charges arising from a prize.

9. Disqualification; market integrity

- 9.1 Organiser discretion: The Organiser may, in its sole discretion, disqualify, exclude, or remove any participant it suspects (acting reasonably) has:
- (a) tampered with or attempted to manipulate the Raffle's operation, systems, or random draw;
 - (b) engaged in fraud, abuse, churning/artificial trading, use of bots/algorithms or other tactics designed only to inflate entries without genuine market purpose;
 - (c) breached these Terms, the Client Agreement, or applicable law/regulation;
 - (d) operated multiple accounts or acted in collusion.
- 9.2 The Organiser may withhold, cancel, or reclaim a prize where disqualification grounds are identified.

10. Amendments, suspension & cancellation

The Organiser may amend, suspend or cancel the Raffle (in whole or part) where required for regulatory, legal, system, security, or market-integrity reasons, or where events beyond its control materially affect the Raffle. Any material change will be communicated via the Organiser's usual channels. No change will retroactively reduce prizes already credited.

11. No advice; no inducement to trade

- 11.1 Participation in the Raffle does not constitute investment advice, an offer, or a solicitation to buy/sell any financial instrument.



11.2 The Raffle is not designed to encourage disproportionate trading activity. You should trade only if such activity is suitable in light of your circumstances and risk appetite.

12. Client Agreement; conflicts

Your Client Agreement with the Organiser (including product disclosures, order execution, fees, margin and risk terms) continues to apply during the Raffle. In case of inconsistency, the Client Agreement prevails to the extent permitted by law.

13. Data protection & publicity

13.1 The Organiser will process personal data in accordance with its Privacy Policy available at its website and the Mauritius Data Protection Act 2017. Winners' first name initial and country may be published only with consent or as otherwise permitted by law; winners may object to such use. Participants may opt out of direct marketing at any time.

13.2 Data may be processed for the purposes of administering the Raffle, verifying eligibility, fulfilling prizes, and meeting legal and regulatory obligations.

14. Liability

To the maximum extent permitted by law, the Organiser is not liable for: (a) any loss not caused by its negligence, fraud or wilful misconduct; (b) technical failures beyond its reasonable control; or (c) any indirect, incidental or consequential loss. Nothing in these Terms excludes liability where it cannot be excluded under Mauritian laws.

15. Complaints

Complaints may be submitted via complaints@doto.com or support@doto.com. The Organiser will handle complaints in line with its internal policy and regulatory obligations. This is without prejudice to any dispute-resolution mechanism in the Client Agreement.

16. Governing law & jurisdiction

These Terms are governed by the laws of Mauritius. Subject to the Client Agreement's dispute-resolution clause, the courts of Mauritius shall have non-exclusive jurisdiction.
